WHAT IS THE CFA PROGRAM?

- The CHARTERED FINANCIAL ANALYST (CFA®) Program is a self-study, three-level exam that tests the fundamentals of investment tools, company valuation, portfolio management, and wealth planning.
- The program is designed to equip candidates with the knowledge and skills necessary to compete and excel in today's complex and evolving investment industry.
- The curriculum is developed by CFA Institute, one of the world's leading associations of investment professionals.
- Candidates who who have completed the CFA® Program and completed acceptable work experience requirements are eligible to apply to receive the Chartered Financial Analyst (CFA®) charter.

WHAT DO I NEED TO DO TO EARN THE CFA® CHARTER?

Pass CFA Exams

CFA Program contains three levels of curriculum, each with its own exam. Passing the exam for all three levels is a requirement to obtain the CFA charter.

3 Submit Reference Letters

In support of your membership application, you will need to provide 2-3 professional references. References will be asked to comment on your work experience and professional character.

Achieve Qualified Work Experience

Complete work experience requirements before, during, or after participation in CFA Program. Your experience must be directly involved with the investment decision-making process or producing a work product that informs or adds value to that process.

Apply to Become a Charterholder

Apply to <u>become a regular member</u> of CFA Institute. Once your application is approved and you have joined CFA Institute, you will have earned the CFA charter.





WHAT IS THE ENROLLMENT CRITERIA FOR THE CFA PROGRAM?

To register for the CFA Level I exam, you must meet one of the following requirements:

- Bachelor's Degree: Complete a bachelor's program or equivalent program and have received a degree from the college/university.
- Undergraduate student: You may enroll in the program while an undergraduate student provided your selected exam window is 23 months or fewer before your graduation month for your bachelor's degree or equivalent program.
- **Professional work experience:** Have a combination of **4,000 hours of work experience** and/or higher education that was acquired over a minimum of **three sequential years** and achieved by the date of registering for the Level I exam. Professional work experience does not need to be investment related.





WHAT ARE THE OTHER REQUIREMENTS FOR ENROLLMENT?

Candidates must also fulfill the following requirements to take the exams of the CFA program

- Valid international travel passport
- Be prepared to take the exams in English

Live in a participating country





WHAT IS THE COST OF THE CFA PROGRAM?

- The applicable rate for exam registration depends on the time of payment. There are two payment deadlines (Early-bird registration and standard registration) for each exam registration cycle.
- From 2026 exams onwards, the enrolment fee for Level I will be eliminated

WHAT ARE THE PAYMENT METHODS FOR THE CFA PROGRAM?

- All payments for the CFA program must be made in US dollars.
- The following payment methods are available
 - Credit cards
 - Alipay
 - Offline payments with an Invoice (available up to 40 days before the close of registration)
 - Personal, corporate, or bank checks
 - Money or postal orders
 - ACH or wire transfer





CAN I GET A REFUND IF I CHANGE MY MIND ABOUT THE PROGRAM?

Refund Policy

- For candidates submitting an initial registration for a CFA Exams, a full refund of your enrollment fee, registration fee, and any other sales tax payable and paid by the candidate in their country of residence is available within fourteen (14) days of payment (through 11:59 PM Eastern Time on the fourteenth day).
- Thereafter, enrolment and registration fees are non-refundable, even in the event of a medical condition or other extreme circumstance.
- Enrolment and registration fees are non-transferrable. Payments for print curriculum orders are nonrefundable once the order has been placed.

WHAT IF I WANT TO RESCHEDULE MY EXAM?

Deferral Policy (Updated as of 7th May 2025)

If you are unable to sit for the exam after registration on the chosen exam day, you may either;

- Reschedule the exam exam appointment within the same exam window.
 - A USD 250 rescheduling fee will apply
- Reschedule the exam appointment to a different exam window.
 - Purchase a paid deferral for USD 499 up until 24 hours before your scheduled exam appointment.
 - A paid deferral enables you to postpone your exam appointment for up to 12 months, depending on your exam level
- Reschedule the exam due to a valid emergency.
 - Scheduled candidates may request an Emergency Deferral for Valid emergencies include lifethreatening illness, pregnancy, and military deployment
 - Candidates must provide documentation to support the claim for an emergency deferral
 - Once the deferral is approved, you may defer your exam appointment for up to 12 months, depending on your exam level.
 - Beginning with exams in 2025, we will charge a **USD 100 processing fee** for all approved emergency deferral requests

DOES CFA INSTITUTE PROVIDE ANY SCHOLARSHIPS?



Access Scholarship

For individuals who may not be able to afford the program fees and are not currently registered for an exam. You are NOT eligible to apply if you are currently registered for an exam and/or are waiting for results to be released.



Student Scholarship

For students currently attending an affiliated university and are not currently registered for an exam. You are NOT eligible to apply if you are currently registered for an exam and/or are waiting for results to be released.



Professor Scholarship

For full-time college/university professors or administrators/department heads who teach a minimum number of credit hours at qualified institutions and are not currently registered for an exam. You are NOT eligible to apply if you are currently registered for an exam and/or are waiting for results to be released.





WHAT IS THE CFA ACCESS SCHOLARSHIP?

- The CFA Institute **Access Scholarship Program** is designed to make CFA® Program more accessible to individuals who may not be able to afford the full program
- Successful candidates would have their enrollment fee waived and exam registration is reduced to USD
 400 plus any applicable tax.
- The Access Scholarship has 4 application windows per year that align with each exam window.
- Access scholarships are valid for only one exam cycle. There is an application window for each exam cycle.
- Applicants will be notified directly by email approximately 4-6 weeks after the application window closes.
- Applicants must meet the enrollment criteria and requirements for the CFA Program to be eligible to apply for the scholarships

WHAT IS THE CFA STUDENT SCHOLARSHIP?

- This scholarship is available to students around the world who are enrolled at school or college participating in the University Affiliation Program.
- Successful candidates would have their enrollment fee waived and exam registration is reduced to USD
 600 plus any applicable tax.
- The Student Scholarship Program accepts applications from 1 September through 31 July.
- Applications will be reviewed and awarded by your university throughout the program year and are not based on a specific exam cycle.
- Student scholarships awarded after 1 September 2024 are valid for 6 months
- If you fail to utilize your scholarship by not registering, not scheduling or not appearing for the exam, you will not be eligible to receive future scholarships.







About the CFA Exams



OVERVIEW OF THE CFA EXAM

- The CFA Program consists of a series of three exams: Levels I, II, and III.
- Each level of the curriculum builds on the prior level and becomes increasingly complex, with a core of ethics and professional standards across all levels.
- The total testing time for each exam is 4.5 hours.
- The CFA exams are conducted exclusively in computer-based formats at one of its 400+ global test centres around the globe.
- The exam are administered by the CFA institutes partners Prometric and British Council.

WHEN CAN I TAKE THE CFA EXAMS?

CFA® EXAM CYCLE AVAILABILITY BY LEVEL

LEVEL I FEB LEVEL III CFA exams are administered on a quarterly basis each year. LEVEL II MAY LEVEL I Level I exams will be offered each LEVEL I LEVEL II AUG LEVEL III quarter, Level II exams will be offered three times, and Level III NOV LEVEL I LEVEL II exams will be offered two times.

- Candidates cannot register for adjacent exams This means that there needs to be a gap of at least 6
 months before you can register for another exam
- This is applicable to those who pass as well as those who fail exams

Delve into supply and demand, the monetary system, inflation, effects of government regulation, and much more.

Study fixed income security types, portfolio benchmarks, and other complex topics.

Alternative Investments

Examine real estate, private equity, commodities, and more.

Quantitative Methods

From time value of money analysis to correlation analysis and regression, learn robust quantitative methods.

Financial Reporting and Analysis

Learn the details of the financial reporting system (emphasis on international standards, IFRS) and analysis of taxes, debt, global operations, and more.

Equity Investments

Study the types of equity securities, equity portfolio measurements, and much more.

Derivatives

Learn about forward markets, future markets, option markets, and more.

Examine the essentials of managing different types of portfolios successfully.

WHAT ARE THE PRACTICAL SKILLS MODULES (PSM)?

- Practical Skills Module (PSM) provide candidates with on-the-job application of what they are learning in the curriculum.
- The PSMs will consist of a combination of videos, multiple-choice questions, guided practice, and case studies.
- The PSM topic may be chosen after registration at any time during your exam study period and must be completed before results are released.
- Each PSM takes 10-20 hours to complete.
- Completion of one PSM at each level is mandatory in order to receive your exam result.

HOW DO I REGISTER FOR THE CFA EXAM?

Registering for a CFA Exam is a two-Step process:

- Step 1: Enroll in the CFA exam
 - Create a Candidate Profile on the CFA Institute website.
 - Make the relevant payment to complete the registration process.
 - The above step must be completed by the **registration deadline** for each exam window.
- Step 2: Schedule your Exam Window
 - Once the payment is processed, you may schedule your exam via the CFA Program tile on your candidate profile on the CFA Institute website.
 - Use the prometric scheduling tool to select the available testing centers with dates and times.
 - Prometric will send you an appointment confirmation email.



You must complete this step by the scheduling deadline for each exam window.



HOW LONG DO CANDIDATES SPEND PREPARING FOR CFA EXAMS?



HOW CAN I SIGN UP FOR THE CANDIDATE COUNCIL?

Who is Eligible to Join?

- i. Already registered CFA Program candidates
- ii. Potential candidates who intend to register within 6 months (Confirmation via e-mail required)

How Do You Join?

If you meet the eligibility criteria;

- 1. Already registered candidates: Make the annual membership fee payment via https://cfasocietysrilanka.org/candidate-council/ Annual membership fee for 2025/26: LKR 5,000.
- 2. Candidates intending to register within 6 months:
